

## European Journal of Commercial Contract Law

### Information for Authors

The European Journal of Commercial Contract Law (EJCCL) is a journal for scientific, high-standard contributions in the field of commercial contract law. Commercial contract law includes e.g. transport law, international sales law and insurance law.

The EJCCL is a *European* journal. This means that the EJCCL does not publish contributions which focus on the law of *one* country/legal system only, unless the contribution adds something very relevant/interesting to the knowledge of legal scholars working outside this one country/legal system. Whether the contribution adds something very relevant/interesting is at the discretion of the editors.

The fact that the EJCCL is a *European* journal, does *not* mean that contributions which focus on the law of, for example, South-American states are not welcome. However, such contributions should be of particular interest to the EJCCL's European readers.

The EJCCL does not accept contributions which have been published before or which have been submitted for publication to other high standard legal journals at the same time or at an earlier stage.

The EJCCL accepts lengthy contributions. However, the preferred maximum number of words is 10.000 (footnotes excluded).

Authors must use the OSCOLA footnote style. The first footnote (\*) must provide information about the author's name, title and current employment. If an author refers to a book, he or she is expected to refer to the latest edition of this book, unless an earlier edition is of special importance.

Manuscript guidelines:

Font: *Times New Roman*

Font size: 11

Font size footnotes: 10

Spacing left and right: 0 pt.

Distance between lines: single

No pictures

Page numbers added

Contributions must be written in a clear and fluent style. A reader must be able to understand the author's intention/meaning swiftly. Paragraph titles should not be too lengthy and should be to the point. Authors must end the contribution with a conclusion or a summary.

Contributions may be submitted to the EJCCL by sending it by e-mail to the editorial secretary and the chief editor.

The author's contribution is reviewed by two members of the EJCCL Board of Editors. The editorial secretary does not review the contribution. The reviewers remain anonymous. This means that the author is not allowed to contact the reviewers. Only the editorial secretary and the chief editor know who the reviewers are.

The author may request the editorial secretary and/or the chief editor to deliver only an anonymized version of his/her contribution to the EJCCL's reviewers.

The reviewers decide whether the author's contribution is suitable for publication in the EJCL, whether it needs improvement or whether it will not be published in the EJCL. If the reviewers disagree with each other, a third reviewer is asked to review the contribution.

If the reviewers advise the author to improve his or her contribution, the author has the choice either to withdraw his or her contribution or to make the requested improvements.

Once the author's contribution has passed the reviewers definitely, the publisher reviews the article for linguistic and grammatical errors. The publisher might suggest improvements to the text.

Authors are asked to be patient. The reviewers work for the EJCL voluntarily. The review procedure is very careful and takes time. If the author has a special interest in publishing his or her contribution at short notice, he or she is requested to inform the editorial secretary as soon as possible.
